

1 Safety Precautions

This instruction manual explains how to use the Compact Laser Diode Module.

Before use, please read this manual thoroughly. After reading, keep it together with the product for reference when necessary. Please retain all original packaging material in the event the unit is stored or shipped in the future.

For non-OEM applications, we recommend following safety protocols for Class 3B products according to latest ANSI Z136.1 Standard for the Safe Use of Lasers.

Use protective eyewear to eliminate potential eye exposure in excess of the maximum permissible exposure levels as stated in either ANSI Z136.1 or IEC-60825-1.



CAUTION – *Use of controls or adjustments or performance of procedures other than those specified herein may result in hazardous radiation exposure. Body of the unit contains labels specifying wavelength and maximum emitted power.*

1.1 Export Control Laws Compliance

It is the policy of Coherent to strictly comply with U.S. export control laws.

1.2 Explanation of Warning Symbols

This documentation may contain sections in which particular hazards are defined or special attention is drawn to particular conditions. 1.3 Signal Words

Three signal words with color coded call-outs are used in this documentation:

1.4 Symbols

This symbol is intended to alert the operator to the danger of Electro-Static Discharge (ESD) susceptibility.




This symbol is intended to alert the operator to the presence of additional important information.

2 Laser and Operational Safety Precautions

2.1 Safety Features For Compliance

This laser system is considered for OEM integration laser system when used without optional keyswitch accessory. When used with the optional keyswitch accessory, the Compact Laser System complies with the United States Code of Federal Regulations (CFR) 21 CFR 1040.10 and 1040.11, except for deviations pursuant to CDRH (Center for Devices and Radiological Health) Laser Notice 50, dated July 24, 2007. The laser system is harmonized with both CDRH and International Electrotechnical Commission (IEC) 60825-1 standards, as a Class 3B (or, IIIb) laser product, and it may emit Visible or Invisible Laser Radiation in wavelengths from 0.4 to 1.064 μm from the Laser Aperture in the front.

The required Classification, Warning Logotype, Aperture, and Information labels are permanently affixed to (or screen-printed on) the housing, along with the Model Number, a unique Serial Number, Date Manufactured, and the units' maximum Output Power and Wavelength. Additionally, the wavelength is also found in the Model Number.



CAUTION – *CDRH Classification is only applicable when used with optional keyswitch accessory.*


2.2 Laser Feedback Warning

Semi-conductor laser diodes are highly sensitive to optical feedback. They can suffer damage that maybe immediately apparent through loss in power or a reduction in life. Furthermore, wavelength stabilized laser diodes may lose their spectral characteristics such as center wavelength and linewidth if sufficient optical feedback exists.

Your Coherent laser diode does not incorporate an optical isolator, so may be susceptible to extraneous optical feedback. We recommend the following precautions:

- If the output of the laser diode is collimated, all reflective surfaces in the optical path should be angled so that surface reflections would not be reflected back to the laser diode. Furthermore, since optimal alignment for interferometric measurement instruments is often achieved with the instrumentation optics at normal incidence to the laser, we recommend the use of optical isolators or slightly misaligning the instrument to avoid direct feedback into the laser.
- Beware of focusing the light output on a highly reflective/scattering surface. This is another means of generating high optical feedback to the diode.
- If fiber coupling, anti-reflective (AR) coated tips are recommended for multimode (MM) fiber. Angle polished tips and AR coating are recommended for single mode (SM) fiber.

- Beware of wavelength selective filters with narrow wavelength pass bands. Care should be taken not to align at normal incidence to the beam. Furthermore, be careful not to align the reflected light to be normal incidence during the alignment process (e.g. sweeping the beam back across the laser during alignment). If such a possibility is unavoidable, use a sufficient OD filter (or isolator) at the output of the laser diode during the alignment process. Please note that if sufficient additional feedback reaches the laser diode, it would overcome the grating-induced stabilization, unlocking and shifting the wavelength of the laser beyond the pass band of the filter. This will dramatically increase the reflected intensity back into the laser possibly causing damage.



WARNING - Laser lifetime may be adversely affected with optical feedback. Momentary strikes on the scale of sub seconds are sufficient to cause permanent damage which could manifest later in diode lifetime.

2.3 Units With Fiber

Units with fiber have special consideration:

- Fiber tips are susceptible to damage due to cleanliness. Output light from fiber tip facet attracts dust and debris when exposed to the environment. Clean and inspect fiber tips before mating. Damage could occur when mating dirty fiber tips.
- Review appendix for possible fiber cleaning solutions.
- Fiber has a minimum bend radius, typically 20mm. Do not bend fiber below 20 mm.
- Do not pull-on fiber. Handle fiber gently and with care.



Damaged fiber tips and fiber due to mishandling or cleanliness are not covered by warranty. Certain types of damage are not repairable.

2.4 Summary of Precautions



To prevent permanent damage, observe these precautions:

1. *Protect against electrostatic discharge.*
 2. *Mount laser to a suitable thermal heatsink*
 3. *Use supplied power supply or power supply meeting specifications.*
 4. *Do not drop the module or operate it at extreme temperatures or humidity.*
 5. *Beware of optical feedback from reflective surfaces. Permanent damage to the laser diode is possible.*
 6. *Inspect and clean all fiber tips before use and mate.*

This device is a compact laser diode module with integrated laser diode current driver and temperature control for high precision equipment and instrumentation. It plays a pivotal role in testing or manufacturing, and can be used in various applications such as Flow Cytometry, Confocal Microscopy, Protein Crystallography, DNA Sequencing, Semiconductor Defect Detection, Thin Film Analysis, High Density Data Storage, and Raman Spectroscopy.






4.2.1 Standard Configuration




4.2.2 Fiber Pigtailed Configuration



5 Operating Procedures

5.1 Standard CW Operation

Laser module can be operated with or without RS232 communication port. Settings can be accessed via push buttons on the laser module as well as RS232 port.

5.1.1 User Startup Procedure:

- Properly mount laser module on a heat sink. **Poor heat sink may result in thermal runaway and permanent damage may occur.**
- If necessary, connect DB9 interface cable
- Connect power supply



NOTICE - Stabilized diodes are based on principles of external cavity lasers. Consequently, they are sensitive to changes in environment. Depending on requirement, consider enclosing laser module, to remove air flow and minimize temperature changes.

5.1.2 Laser Module Startup Process:

Laser module controller will follow/indicate the following process after power on:

- With default shipping configuration of a password of 0000, system will automatically cycle through initialization routine and emit optical power. Changing the password from 0000 will cause the system to wait for password prior to completing initialization routine. Hence, default password of 0000 allows for hands off (computer control if needed) usage. Password other than 0000 would require user input prior to any computer communication or emission of light.
- The power LED on indicates the controller has received power. Default operating conditions are stored in onboard flash.
- The TEC activates to stabilize temperature to temperature setpoint. Setpoint can be changed via RS232 or push-button interface. It will take a few seconds depending on the setting point and environmental conditions. During this period the status LED will flash rapidly.
- Wait 30 seconds before the laser diode emits the power and the status LED will keep flashing fast. Laser controller only operates in constant current mode. Status LED flashes according to table above

5.2 Push Buttons and LCD Display

The laser controller has 4 push buttons (“MENU”, “UP”, “DOWN”, “ENTER”) and a 2x16 LCD alphanumeric information display. The pushbuttons are used to change various controller settings and laser operation parameters. “MENU” is used to enter or to exit the menu level. “UP” and “DOWN” are used for navigation and change values. “ENTER” chooses menu levels and confirms settings.



CAUTION – Controls do not have limit checks to validate input. Incorrect values inputted could permanently damage laser diode.

Warranty does not cover scenarios where improper values are inputted.

- Version display. The LCD shows the software version information for 5 seconds when the unit power is on

Entering password (if changed from default password of 0000). If password is entered incorrectly for three times, the unit would be locked until power is cycled (unplug and reconnect power cord).

- Wait for temperature stability after the unit power is on. Temperature setpoint is based on stored setpoint. Display shows actual temperature and TEC current:

- Wait 30 seconds for temperature stability. Display shows time countdown:

- Settings Display.

The setting menu block is selected by pressing “**MENU**” in a normal running mode. Within the menu block, pressing “**UP**” or “**DOWN**” navigates between menu items. Press “**ENTER**” to select the item. Pressing “**MENU**” will exit the setting menu without saving the changes to flash. All the settings will go back to the previous setting after the unit is reset or re-powered

Press “**ENTER**” to change the temperature set point. Otherwise press “**UP**” or “**DOWN**” to change the setting menu

After pressing “**ENTER**” the unit will enter the parameter setting mode and the cursor will change from “S” to “2” which is the first digit of the parameter. Then press “**UP**” or “**DOWN**” to change the digit from “0” to “9” or “.”. After finished setting this digit, press “**ENTER**” to move to next digit. When you finish setting the last digit and press “**ENTER**” the parameter will affect right away then the cursor will revert to “S” at the same time. All the following parameter settings are the same

Press “**ENTER**” to select TEC operation and the cursor will go down to the “O”. Then pressing the “**UP**” or “**DOWN**” will set TEC on or off. The TEC will not turn on or off until pressing “**ENTER**” to confirm the operation. Pressing “**MENU**” will cancel the change. All the following setups for selecting ON/OFF or Disable/Enable are the same as the TEC operation

CAUTION – Maximum AAC current shown on the controls is the maximum current capable by the circuit. Diode should not operate at circuit maximum current. Diode capabilities are limited by optical

power. Application of circuit maximum current would definitely shorten life of diode.

Press “**ENTER**”, and then press “**UP**” or “**DOWN**” to change the run mode to “Internal Modulation” or “Default”. Settings change only takes effect when exiting the setting menu. “Internal Modulation” is unsupported and should not be used

All the setting parameters will be saved to flash memory. So the laser will keep this setting even when the unit is reset or repowered

5.3 Operation via Communications Port

The laser system includes complete remote-control capability through RS232. All RS232 commands are available after laser system auto start



CAUTION – Controls do not have limit checks to validate input. Incorrect values inputted could permanently damage laser diode.

Warranty does not cover scenarios where improper values are inputted.

5.3.1 Baud rates and serial port settings

Each controller is shipped from the factory with a fixed 9600 baud, which cannot be changed.

The other serial port parameters are: 8 data bits, 1 stop bit and no parity. A hardware flow control is not supported.

5.3.2 Command formatting and termination characters

Each command to the controller must be terminated by a carriage return/line feed pair (ASCII 13 followed by ASCII 10).

All commands are case-sensitive.

Command arguments must be delimited by a single colon ':' character (ASCII 58).

5.3.3 Handshaking

Under no circumstances will the controller initiate communication. It only transmits characters in response to a message. Every message to the controller generates a response, either a numerical value or the acknowledgment string "OK". In the event that the controller receives a message that it cannot interpret, it responds: "ERROR". Every controller response is terminated by a carriage return/line feed pair (ASCII 13 followed by ASCII 10, also known as "\r\n"). See Appendix for sample setup using Putty.



5.4 Remote Key Switch Operation (Required for non-OEM Customers)

[VERSION 2]



1. **Power on/off key switch**—Located on the front panel of the Remote Key Switch, this switch enables users to power the unit on with the turn of a key. The unit is inoperable when key is removed.
2. **Emission indicator**—This red LED, located to the upper right of the front panel, lights up when the unit is on to warn of eminent laser emission.
3. **Remote interlock & connector**— This feature is located on the rear panel of the Key Switch. The unit will not operate without the interlock intact. Interlock needs to be shorted for power to be available for laser diode module. A shorting bar is connected by default.

5.4.1 Remote Key Switch Procedure:

- Plug power adapter into Remote Key Switch Box.
- Use key to activate and deactivate power to the laser module. After key switch is turned to “on” position.
- Emission warning light will light up upon key switch turned to “on” position.
- Laser system is “off” when key is in vertical position.
- Interlock must be “shorted” for power to be applied to laser module

6 Maintenance

6.1 Maintenance and Inspection

Routine maintenance is not required. If the unit appears to be operating incorrectly or with low output power, check the following:

- Inspect the enclosure for scratches, dings, dents, or other signs of damage due to handling.
- Verify that the module enclosure has not been opened and the factory seal is intact.
- Verify power source connections to the laser module.
- Ensure that the operating environment is within specifications.

7 Service And Warranty

7.1 Repair

There are no user-serviceable parts inside and do not attempt to open housing. Warranty would not be valid if housing has been opened. If the module fails during use, check the items in section 5.1 before requesting an RMA.

Defective modules that are beyond the warranty period will be repaired at cost, if possible. An RMA must be requested before sending it to Coherent. When shipping, please use a box at least five times as large as the module with enough packaging material to prevent any movement of the module within the box.

7.2 For Information or Enquiries

If you need information regarding purchase or repair, or for any other Sales related questions, please contact the distributor or selling agent from whom the module was purchased.

7.3 Coherent Limited Warranty

Coherent warrants that all SureBlock™ TR-Probe THz-Raman systems will be free from defects in material and workmanship for 12 months from the date of shipment. This limited warranty covers only those defects that arise as a result of normal use of the product, and does not cover any other problems, including those that arise as a result of: (i) improper handling, maintenance or modification, (ii) operation outside the product's specifications; or (iii) unauthorized modification or misuse.

If Coherent receives, during the applicable warranty period, notice of a defect in any product which is covered by this warranty, Coherent shall either repair or replace the product, at Coherent's option. Coherent shall have no obligation to repair, replace or refund until the customer returns the defective product to Coherent. Any replacement product may be either new or like-new, provided that it has functionality at least equal to that of the product being replaced. 



8.1 Sample communication setup using Putty


Download and install Putty, a popular open-source terminal program. Select serial once program has started:



Change flow control to none




Type in appropriate serial port connected to laser




Go to Terminal and select the following:

Local Echo : Force On

Local line editing: Force Off



Go to Session and make sure the serial port is correct and hit Open:



Now it looks like this:



try typing in
rtt?



followed by

Ctrl-M

Ctrl-J

Ctrl-M and Ctrl-J represents carriage return and line feed (/r/n). A response should ensue.



Sessions with Putty require the command line to be followed with Ctrl-M Ctrl J since it is the method of entering the line termination string (\r\n).

9 Fiber Cleaning

9.1 Importance Of Maintaining Clean Fiber-Connections

To ensure optimal performance of the laser system, it is crucial to maintain a pristine FC/PC connector on the unit and at the tips of the delivery fiber. Any contamination on the ends of the fiber connections can lead to undesirable performance outcomes and, if not addressed, may ultimately result in the failure of components or the entire system. There are also less apparent or even invisible contaminants that can cause unwanted attenuation, optical noise, or subpar performance. Examples include oils (e.g., from fingerprints), film coatings (e.g., condensates from vapors in a test chamber), and other residues (e.g., after the evaporation of water or solvents, dust, etc.). Furthermore, the laser output intensity at the very end of a fiber tip is so high that a small contaminant can be burned onto the end if it obstructs the core during operation at higher powers. This burn can damage the optical surface to the extent that it cannot be adequately cleaned, necessitating the replacement of the delivery fiber.




Figure 9.1-1: Contrast between a contaminated and clean Fiber-tip, as-viewed under magnification



NOTICE - When cleaning fiber components, always complete the steps carefully, and wear nitrile gloves when handling fiber-ends. NEVER touch the fiber end-face with bare fingertips, even if “clean”. The goal is to remove all dust and contamination to provide the cleanest mating surfaces possible for the optical connections. Remember that inspection, cleaning and re-inspection are very important steps which must be done before you make any fiber connections.



WARNING! – Always turn the unit OFF before you inspect a connected-fiber tip and/or clean the unit FC/PC connector:

Never look into a fiber-end or the output aperture , while the Laser Enable keyswitch is in the ON position, even if the ‘E-Stop’ and/or other safety-interlocks are open and laser emission is not occurring.

Never attempt to inspect a fiber-end with a fiberscope while the laser is ON or operating.

Never use the eyes to verify laser emission, gauge power levels, or evaluate fiber-tip cleanliness' once the laser is ON and operating.

9.2 Cleaning the Fiber Connector

Moreover, the instructions given herein are intended as general guidelines and should not be considered exhaustive or comprehensive. It is important to note that fiber-cleaning methods and recommendations may vary between manufacturers and tools. As Coherent cannot dictate the choice of cleaning products or tools a customer may select, it is strongly advised to carefully adhere to the fiber tip cleaning instructions outlined in the User Manual for each specific product.*

Coherent recommends use of either the US Conec IBC™ Brand Model 9392 (or, alternatively, Model M250) 'one-click' style FC/PC connector-cleaners each time before freshly-mating a new delivery-fiber to the unit

NOTICE - *No known cleaning method is absolutely 100% effective. Thus, it is imperative that inspection is included as an 'integral part' of your cleaning process and protocol. Incorrect cleaning can damage the fiber, and/or the laser internally.*

9.3 Inspecting And Cleaning Delivery-Fiber Ends

Inspection of delivery-fiber ends are done with either a desktop video-fiberscope or a hand-held fiberscope. Both tools are specialized microscopes used for inspecting optical fibers. Any scope chosen should provide

at least 200x total magnification. **Specific adapters may be needed for FC/PC connectors** to properly inspect the Fiber-tip. Figure 9.3-1 provides examples of popular scopes.

To inspect a delivery-fiber tip:

1. Make certain that the laser is turned OFF before starting inspection.
2. Put the applicable inspection adapter or probe on your equipment.
3. Unscrew and remove the delivery-fibers' dust cap.
4. Insert the delivery-fiber connector into the fiberscope adapter and adjust the focus ring until you see a clear fiber tip image.
5. Clean the fiber tip and re-inspect, as necessary. See below for an overview on fiber tip cleaning.
6. Immediately plug the clean connector into the connector it will be mating-to decrease the risk of re-contamination.

Dry Cleaning Technique

The recommended dry-cleaning technique utilizes a 'cartridge' cleaning tool. Coherent recommends use of the following cartridge cleaning tools and associated techniques. (source-websites, valid as-of the time of this writing).

NOTE— Since fiber-cleaning techniques and advice can vary from manufacturer-to-manufacturer (and tool-to-tool), and Coherent cannot 'control' what cleaning product or tool a customer may choose to purchase, it is simply recommended to closely follow the Fiber-tip cleaning instructions provided in each products' User Manual.

Wet Cleaning Technique

1. Make certain that the laser is turned OFF before starting cleaning.
2. Carefully remove the delivery-fibers' dust cap.
3. Inspect the fiber-tips with a fiberscope. (See Figure 9.2-1, above)




Figure 9.3-3: 'Figure 8' Wet-cleaning a fiber-tip with a 'cleaning pad' made from optical-grade lens paper.

4. If a tip is dirty, clean with a cartridge cleaner, as-per the manufacturer's instructions – or – follow a simple 'Wet-to-Dry wipe' technique, as-follows: (Also see Figure 9.3-3, below)



CAUTION – Follow all safety instructions when using isopropyl alcohol and/or methanol (used for wet cleaning of the fiber tip). If you do not have a copy of the safety instructions and MSDS sheets for using IPA or methanol, contact your Industrial Safety Dept. before following the cleaning information described in this document.

1. Start with a fresh sheet of lint-free, optical-grade lens paper, folded 3 times, to yield a cleaning surface with '8 layers' of folded material. Be
2. careful not to touch or contaminate this cleaning 'pad'.
3. Carefully drop spectroscopic-grade isopropyl alcohol ('IPA') or methanol onto the pad, until the 'wet area' is approximately the size of a penny.
4. Ensure that an area of the cleaning pad remains dry.

5. Place the 'pad' just created on a clean, smooth work-surface, and bring the fiber tip to a perpendicular-angle to the pad, and lightly contact it against the surface of the pad.
6. With very light pressure, and holding the tip to the cloth, 'wipe' the fiber tip lightly across the Wet area of the pad, using a 'scalloped Figure 8' motion. Do Not 'scrub' back and forth! At the same time, gently rotate the fiber-tip 90 – 180 degrees, maximum.
7. Immediately repeat this same action on a clean, dry-section of the pad to remove any traces of solvent. Again, Do Not 'scrub' back and forth!



NOTICE - *Improper 'Wet' techniques can complicate fiber tip cleaning and should only be used when all dry, 'cartridge-tool based' techniques have failed to clean the tip sufficiently. The primary concern with using solvents is if it is not removed completely from the tip, residual liquid acts as a transport mechanism for loose debris elsewhere on the end-face. If the solvent is simply allowed to evaporate slowly off the end, it can leave residual contaminant on the fiber core. This is extremely difficult to clean off without another Wet cleaning and usually more difficult to remove than the original contaminant. Excess solvent can also remain in tiny 'surface-pits' where it can re-emerge upon fiber connection.*

Additionally, 'scrubbing' the fiber back-and-forth on the pad or wiping over the same area more than once can re-contaminate or damage the Fiber-tip.

Summary:

1. Inspect the delivery-fiber tip with a fiberscope or microscope, as per the instructions above. If the tip is dirty, use the Dry-cleaning technique to clean it, as-per the instructions above.
2. Re-inspect the fiber tip. If the connector is still dirty, repeat the Dry-cleaning technique, as-per above, a second time.
3. Re-inspect the fiber tip again. If the connector is *still* contaminated, clean it with the Wet cleaning technique, as per the instructions above.
4. Re-inspect the fiber tip again. If the contaminate is still present, repeat the Wet cleaning process, as per above, until the fiber tip is clean.

If the delivery-fiber tip is *still* contaminated after several cleaning attempts using both the Dry and Wet cleaning techniques, contact your technical support




Figure 9.3-4: An example of a fiber cleaning process flow
